

# BREEDING CONTRACT

Under the terms of this agreement, the undersigned parties agree to the following conditions in regard to the breeding of the Golden Retrievers identified below:

## STUD DOG OWNER RESPONSIBILITIES

The owner of the above named stud dog agrees to the following:

1. That this service will be provided by the above named stud dog to the above named bitch during her next heat season.
2. That this service will be provided as soon as the bitch will stand and the service will be repeated every other day for a total of 2-3 breedings, if possible unless otherwise agreed upon by both parties.
3. That 3 live viable puppies 48 hours after birth constitutes a litter:
  - a. If only 2 live puppies result, the stud fee will be pro-rated at \$200 for first puppy, \$150 for the second puppy.
  - b. If no live puppies result or the bitch does not conceive, a repeat service will be provided within 12 months to the same bitch if the stud dog is available with the initial fees paid being applied toward the repeat breeding.
    - i. If no live puppies or no conception occurs, the bitch owner is entitled to a refund of all initial stud fees paid except for the \$100 fee if the bitch owner chooses NOT to repeat the breeding to the above mentioned stud dog.
4. That the stud fee for this breeding is \$ 500.00 or first choice of a pup (stud owners choice) with a \$200 fee paid prior to the breeding taking place unless a pup is agreed upon. The rest will be due before signing the AKC registration papers.
5. That copies of the required health testing if a natural breeding of the bitch will be given to the stud dog owner prior to the breeding. If copies are not received, the bitch will not be bred to the above named stud. (Brucellosis).
6. That the owner of the stud dog will contact the bitch owner in the event the stud dog develops a serious hereditary defect.

## BITCH OWNER RESPONSIBILITIES

The owner(s) of the above identified bitch agrees to the following:

1. That the stud fee will be paid in a manner mutually satisfactory to both the owners of the male and the bitch. A \$200 fee to be paid prior to the actual breeding with the remaining balance due at the time the registration papers on the resultant litter are signed by the stud owner.

- a. That the stud owner has the option of "pick puppy" in lieu of the monetary stud fee. This desired option will be communicated to the bitch owner at the time of whelping and will depend on the number of pups produced. "Pick puppy" constitutes any pick before any pups leave the litter.
  - b. In the case of the bitch owner's desire to keep a puppy from the litter, the stud dog owner agrees to 2<sup>nd</sup> Pick puppy" in lieu of the monetary fee.
  - c. If only one puppy results from a "pick puppy" litter, the bitch owner will be required to submit the monetary value of that puppy (\$200). "Pick puppy" for the stud dog owner would be forfeited.
2. That copies of the required health testing on the stud dog will be given to the bitch owner before the bitch arrives for breeding. If no health testing papers are available, no breeding will take place.
  3. That the bitch owner is responsible for all transportation and vet fees related to the bitch's breeding, care and maintenance.
    - a. Boarding is free for 4 days. Any amount of time after the 4 day period will be \$15 per day.
  4. That the bitch will be delivered in good health, free from internal and external parasites.
  5. That the bitch owner will furnish the stud owner with the names, addresses and phone numbers of all puppy buyers.
  6. That no puppy from the resultant litter will be sold, given, or traded to pet shops or any commercial or wholesale outlet.
  7. That the bitch owner will contact the stud dog owner in the event the bitch or any of the resulting puppies develop a serious hereditary defect at any time.
  8. Any artificial insemination and/or chilled semen expenses are the full responsibility of the bitch owner.
  9. The semen is to be used on the above named bitch and all leftover semen is to be destroyed.

**OTHER CONDITIONS:**

The owner of the stud dog reserves the right to refuse breeding to the above named bitch if, upon arrival:

1. Any of the above requirements are not met.
2. The bitch has a disqualifying fault (i.e.: severe over or under bite).
3. The bitch is not of acceptable temperament.

**REQUIRED DOCUMENTATION OF HEALTH TESTING AND VACCINATIONS:**

1. Copy of OFA Certification (Only bitches with a rating of Fair, Good or Excellent will be bred) Prelim OFA results may be accepted at the stud dog owner's discretion. Copy of PennHip will also be accepted with a qualify rate of 60% or above.
2. Copy of Negative Brucellosis test within 2 weeks of breeding (recommended but not required for chilled semen breedings)
3. Copy of current Rabies, DA2PP, Bordetella vaccinations.

**RECOMMENDED HEALTH TESTING**

1. CERF Exam or eye exam performed by a Board Certified Veterinary Ophthalmologist
2. Muscle Myopathy Test.
