## **HEALTH GUARANTEE:**

This puppy is sold with a 7 day health guarantee. We guarantee this puppy to be in good health at the time of sale and suggest you have this verified by your veterinarian. If the purchaser is not satisfied with the puppy's health, the puppy can be returned within 7 days of purchase for a full refund or a replacement puppy if one is available.

**PUPPY REPLACEMENT WARRANTY:**

The breeder warrants this puppy against hip dysplasia (OFA), hereditary eye disease (CERF) and hereditary heart disease (SAS) for the first two years of age.

If the dog is dysplastic and not certifiable by OFA, we require written certification of the dysplasia by the veterinarian of OFA. The warranty only applies to x-rays taken between the age of 12-25 months old. If the bitch or male is used in breeding before the x-rays have been evaluated, this portion of the contract is null and void. Upon diagnosis of dysplasia the breeder will replace the dog with a puppy of like quality (does not include any training, etc) when available at which time the dysplastic dog must be spayed or neutered. Proof of this must be submitted to the breeder before a replacement pup will be provided.

Instead of a replacement pup, if the purchaser elects to keep the dysplastic dog without a replacement, the breeder will refund 1/3<sup>rd</sup> of the purchase price upon submission of the proof that the dysplastic dog has been spayed or neutered.

This contract is only valid with the original purchaser of the puppy. It is not transferable.

In an effort to be a responsible breeder, we request that you contact us with any other significant health issues that your vet feels may be hereditary.
